Community Solutions is a program of the [Bureau of Educational and Cultural Affairs of the U.S. Department of State](#) designed to match talented midlevel professionals from developing countries with older, more experienced mentors (*that's me!*) in the US who are working in their field.

Check out this film, [The Water Women](#), which features the work Rose has been doing since returning to her home in Kakamega, Kenya. Congratulations Rose! GEAA is so proud to have played a part in encouraging women to employ rain water harvesting in the rural communities of Kenya.

Since August, [Jacques Nsengiyumva](#) has been working with us as GEAA's second Fellow sponsored by the Community Solutions Program. Jacques is the Environmental Standards and Regulations Officer for the Rwanda Environment Management Authority in Kigali, Rwanda.



He is working with GEAA and the College of Architecture at UTSA on our [Community Rain Gardens project](#). Jacques will apply what he learns about [Low Impact Development techniques](#) when he returns to Rwanda, where he will collaborate with high schools and universities to create engineered wetlands to clean up sewage effluent. While Jacques has been with us, he has toured the water quality laboratories at the [San Antonio River Authority](#), worked with UTSA students on their entry for the [EPA's Campus Rainworks Challenge](#), learned about sources of

funding for his projects in Rwanda, and attended [SXSW Eco](#), where he met with potential sponsors. We are grateful to everyone who has helped to ensure that Jacques' fellowship with GEAA advances his ambitions to improve water quality in Rwanda.
