## Contested Case Hearing and TCEQ Final Decision

- State Office of Administrative Hearings (SOAH) Preliminary Hearing
- Discovery Period
- Hearing on the Merits
- Administrative Law Judge Proposal for Decision (ALJ PFD)
- =180 days SOAH Prelim Hearing to ALF PFD
- TCEQ Commissioner meeting 44 days from Request for Hearing; Preliminary Hearing in January, Contested Case Hearing in March/April; ALJ Proposal for Decision in June 2021.
- TCEQ Commissioner Final Decision

#### GEAA Standing = Affected Person + Member of GEAA


- Affected person = a person who has a personal justiciable interest related to a legal right, duty, privilege, power or economic interest affected by the administrative hearing. An interest common to members of the general public does not qualify as a personal justiciable interest. Texas Water Code 5.115; 30 Tex. Admin. Code 55.103.
- Personal justiciable interest: 1) location and distance relative to the proposed facility or activity 2) how and why the requestor believes he or she will be adversely affected by the proposed facility in a manner not common to members of the general public. 30 TAC 55.201(d)(2).
- Commission may consider...the likely impact of the regulated activity on the health, safety, and use of the property of the hearing requestor...any other expert reports, affidavits, opinions, or data submitted by the applicable deadline. Texas Water Code 5.115.

#### **TCEQ Standing Helpful Items**

- Individual owns property within 1 mile of the facility; Individual's activities or interests that will be affected by application.
- Individual's use of property and/or active use of natural resource for recreational, commercial, scientific and religious purposes.
- ► Use is continuing.
- Use would be impacted by granting of application.

#### Items to include in hearing requests

- Name, address, phone number.
- Description of use of property or other legal interest that will be impacted by wastewater treatment plant and subsurface drip irrigation disposal of wastewater.
- Photos of use property/use of property.
- At later date will be required to provide same information as sworn testimony.

#### Example Description of Standing Member

Jane and John Doe ("Does"), 1234 Madeup Street, Beautiful, Texas, (512-xxx- xxxx) are group members that use and enjoy their property along A Pristine Hill Country Creek for multiple activities that rely on the high quality water of the creek including recreation, wildlife habitat, bee cultivation, agricultural use, religious services, scientific study, and archaeological studies. The Doe's property is approximately 1.5 miles downstream of the proposed wastewater facility and surrounds both sides of the creek. The Does rely on water from their domestic water well for water for their home. The Does will be affected by the proposed wastewater facility in a manner not common to members of the general public because they own property on along the creek and frequently recreate in the creek from their property. The water of the creek is exceptionally clear when it runs through their property and much of their use of their property relies on the clean water in the creek. The Does are affected persons because they have a personal justiciable interest related to the use and enjoyment of their property on the creek. Because the proposed wastewater facility will change the quality of water in the creek there is a reasonable relationship between their interest in the use and enjoyment of their property as abutting a clear and clean creek and the permitting of a wastewater discharge into the creek. Because the water supply for their home is provided by their well, there is a reasonable relationship between their interest in clean and safe drinking water for their home and the permitting of a wastewater facility introducing wastewater adjacent to the creek a short distance upstream from their water supply well. As affected persons with interests that will be affected by the proposed facilities the Doe's request a contested case hearing.
