SEN. JOSÉ MENÉNDEZ SD 26

Though he did vote for HB 5 (an unneeded corporate subsidy), Menéndez was an amazing and successful champion of clean energy and ratepayer interests. He worked hard to pass SB 2453 (a bill that would have made buildings more energy-efficient... but that was vetoed by the Gov). He also authored and carried a good demand response bill, and was able to pass a couple amendments to improve other bills related to the grid.

SEN. SARAH ECKHARDT - SD 14

Eckhardt was one of the top environmental champions in the Senate again, authoring and spending political capital to fight for \$B 258, which would have increased energy efficiency goals for the first time since 2011. The only blemish on her voting record was a Yes vote on HB 5, which offered tax breaks to big polluting companies but expressly excluded wind and solar (though her vote was in return for some changes made by the author).



SEN. CHARLES PERRY SD 28

As Chair of Water, Ag, and Rural Affairs, Perry had considerable power to move positive water legislation this session, but he consciously and deliberately chose not to support (or outright blocked) bills & amendments related to the Economically Distressed Areas Program, which helps residential areas where there is poor or no water & wastewater service. We do credit him for filing and passing one good bill (58 1289) on reclaimed wastewater.



SEN. NATHAN JOHNSON - SD 16

This session we noticed Johnson seeking out points of leverage to advance good legislation and weaken bad legislation. However, tradeoffs and deals all come with costs. He voted the wrong way three times, but we give him credit for authoring a bill that would have benefited economically distressed areas, carrying a good distributed energy and demand response bill, and offering amendments to improve some bad bills.
