

HB 4852 Action Guide

<u>HB 4852</u> would expand the Texas Attorney General's power to target nonprofits and businesses, by allowing the office to demand internal records, compel sworn statements, and even shut down organizations – mostly without the need for court approval or any evidence of misconduct. The AG has already used this statute to attack groups that serve immigrant communities, engage in advocacy, or simply don't align with the AG's agenda.

The House State Affairs Committee will hear HB 4852 on Monday (4/28) at 8am. You can find the hearing notice <u>here</u>.

- 1. Come testify or drop a card on Monday against HB 4852
- 2. Call committee members and urge them to vote no on HB 4852 (committee contact info below)
